

IVEY GUIDELINES FOR USE OF COPYRIGHTED MATERIAL

This note is to remind you of the policies and practices regarding use of copyrighted material in class, for exams, and elsewhere within the school. Ivey has a huge investment in its copyrighted case collection and other intellectual capital. International copyright laws are designed to protect this investment. All materials, including those belonging to Ivey, Harvard, Darden, and other collections, are subject to both copyright regulations and contractual obligations.

What is copyright-protected?	Once something is in a fixed format, such as e-mail, hand-written notes, power-point slides, or even a diagram, it is protected by copyright – even if there is no copyright note on it. Permission from the copyright holder is required before material can be copied and/or distributed.
Rights of the copyright holder	Only the copyright holder has the right to decide who can copy or distribute their work (or decline to grant it) and determine the fee they wish to charge for that privilege. Anyone who copies or distributes someone else’s work without permission is in violation of copyright law.
Ivey Publishing’s role	<p>Ivey Publishing is responsible for obtaining copyright permission for all materials distributed to students as part of their class activities, whether the material comes from the internet, a book, a scholarly journal, a trade magazine, or some other source. Even if there is no fee, Ivey Publishing must request permission from the copyright holder or report usage to a supplier each time the material is used. Copyright permissions are granted for one-time use only. Costs for these permissions are added by Ivey Publishing to course materials packages. Requests for all materials for Ivey programs MUST be submitted to Ivey Publishing to protect the School, faculty, and Ivey Publishing from hefty fines that can result from copyright infringement.</p> <p>As copyright is a complex subject, Ivey Publishing has the responsibility for interpreting copyright law and dealing with copyright holders. Ivey Publishing has developed a data base of copyright holders, the appropriate contact person, their rules for attribution, the fees that apply, the items which cannot be used, etc. As a consequence, permission can often be obtained quickly.</p>

<p>Classroom and exam use</p>	<p>Reproduction of any materials to be used in the classroom or in an exam by students must be requested through Ivey Publishing. Ivey Publishing will determine the need for and obtain any necessary copyright permissions, and add the appropriate copyright statement to the documents before printing. These permissions protect Ivey from legal penalties.</p>
<p>Fair dealing</p>	<p>Under Canada's copyright laws, fair dealing is the right to make a single copy of copyrighted material for personal use (private study, research, criticism, review) without asking permission from copyright holders. Other uses, particularly for classroom use, are not covered under this concept and permissions must be obtained.</p>
<p>Academic exception provisions in Canadian copyright law</p>	<p>Display of materials is permitted (as in an overhead slide) without obtaining permission. Other minor exceptions exist, but are under review. Please check with Ivey Publishing for permissions status before proceeding with course materials.</p>
<p>Internet-sourced materials</p>	<p>Even though material is easily obtained through the internet, copyright laws and regulations still apply. Websites contain copyrighted information, even if not noted as such, and permission to use material must be obtained. Do not assume that you may use material from a website, because some copyright holders will not authorize the copying and distribution of their content.</p> <p>Check the terms and conditions of websites for more details. Many sites prefer students to access their content individually, This provides valuable usage data by measuring the number of times the material was accessed on their site. In these cases, please provide the link to students so they can access the content directly, and ensure the content is not gated behind a paywall that would require students to purchase access.</p>
<p>About email</p>	<p>Sending copyrighted material via email, including watermarked inspection copies, is considered "copying and distributing", and is therefore a violation of copyright law. Please ensure you have permission before sending any materials via email.</p>
<p>Can we add, remove, or change information on copyrighted material?</p>	<p>NO. You must have written permission from the copyright holder to make ANY changes to the original document, Any additional information must be completely separate from the original and not appear to be part of the document</p>

Academic institutions are subject to increased scrutiny. Fines and legal penalties can be applied when copyright law is violated.

BE COPYRIGHT COMPLIANT

Abide by both the spirit of the copyright law, and the actual regulations, when dealing with copyrighted material and copyright owners.
